Payment is secured through deed of trust and promissory note, along with receiving a commission as the listing agent.

The Renovation Realty leadership team provides a mix of skills, expertise and local connections to help renovate and market a range of residential listings, from single-family homes and townhomes to condominiums and two to four unit properties. With 40 years of combined experience and more than 200 successful renovations and sales since 2008, the team provides a turnkey service that is helping property owners, estate/probate attorneys, fiduciaries and trust departments and others turn sometimes distressed properties into valuable assets that often receive multiple offers when listed.

The leadership team members include:

***Keith Christian, Chairman***

Keith Christian oversees new contracts, client relations and co-manages project development. A native San Diegan, Keith has extensive experience in residential real estate and renovations, working for the past 22 years in real estate investments, renovations and sales. Throughout his career, Keith has negotiated, purchased, managed and sold more than 650 single-family homes and 1,300 apartment units.

In addition to his work with Renovation Realty, Keith serves as managing member at Hughmark Homes, LLC, in San Diego, where he oversees renovations and the purchases of single-family homes. Keith is a

licensed California real estate agent, and has experience representing residential buyers, sellers and investors.

Prior to his work with Hughmark Homes and Renovation Realty, Keith was founder and president of Eco Building Systems, Inc., where the company developed Ecocrete, a patented glass fiber reinforced concrete material and manufacturing system for modular and panelized structures. He was responsible for financial, sales, marketing and product development aspects of the business, including patent, licensing, legal, customer relations and capital. The company purchased and developed residential land for 87 homes, manufactured 182 single-family modular homes, and negotiated, received contracts and completed 212 projects for California school districts and private schools. The company raised \$8.6 million from venture capital and private investors, licensed Ecocrete technology and installed factories in Greece, the Czech Republic, Germany, Mexico, Nigeria and the United Arab Emirates.

Prior to Eco Building Systems, Keith was co-founder and President of The Torrey Group, Inc., a real estate investment company. The company purchased, renovated and sold single family homes and apartment's complexes in San Diego and Texas.

***Cannon Christian, President***

Cannon Christian oversees the day-to-day operations of the company, focusing on business development, marketing and sales. He also specializes in accounting, finance and human resources for the company, as well as research and financial analysis for prospective clients.

Cannon also serves as vice president of Hughmark Homes, LLC in San Diego, where he is responsible for market research and presentation of potential investment properties to partners. In his role, he has overseen and managed financials for 28 properties since 2008 with a disposition price total that exceeds \$7 million.
